## **EastEdge Show Rules**

### **Arrival**

Show Grounds will be open at 12:00 pm on the Friday before the show. Trailer Parking will be restricted to Trailer Parking Lots only. These will be well marked areas, please use the space respectfully, and clean up your mess.

\*\*ALL horses coming onto the property for this event must have proof of NEGATIVE COGGINS within the last year. This should be emailed to the office along with your entry fees and forms.

\*\*\*All Current Provincial COVID19 protocols will be in place. Spectators are welcome! There will be no food services at this event.

### **Attire**

Competitors must be clean and neatly dressed in English attire for English classes, and Western attire for Western classes. ASTM or BSI approved helmets **MUST** be worn by all riders any time they are mounted.

All entries must be paid for in full, before they are considered registered for the show. Please e-transfer all applicable show fees to the email address listed above. Late entries will be charged a late fee of \$25 per entry. In the event of cancellation for an entry, a veterinary certificate or physicians note must be presented, Admin fees will not be refunded.

### Liability

- It is to be understood that neither Elevation Equestrian, EastEdge Equestrian, SHF, the show committee, judges, volunteers or manager shall be in any way liable for any accident, injury, damage or loss that may happen, from any cause or circumstances whatsoever, to competitors or anyone on the ground during the competition (including warm ups) or to any animal or property brought on show grounds or for any loss, claim, matter, circumstance or event in connection with or arising out of or attributable to the show or any journey to and from the show.
- Acknowledgement of Risk form must be signed by all riders or guardians before they ride.
- All horses will BE REQUIRED to wear numbers at all times. We will not be providing bridle numbers for competitors at this show. Please ensure you have a set of numbers on their halter as well as their bridle.
- Schooling will only be permitted in the arenas, paid warm ups in the show ring are available on the entry form. Friday evening or Saturday MORNING 6:30 to 8:00. Warm ups are \$20 for half an hour block (can be shared), this must be paid before you ride. Please specify the times you want on entry from.
- There will be photos and videos taken at this show, and there is a high likelihood they will be posted to social media

### General Rules

1. No smoking ANYWHERE on the grounds except in the designated smoking area.
2. No pets.
3. All riders must be members of the SHF, this number must be added to your entries.
4. No lunging in warm up arena or near show ring during show hours. Lunging can be done on grassy areas near the show barns.
5. Any exhibitor not ready to enter the show ring when called will be allowed a period of 2 minutes to enter, after which they will be eliminated without refund.
6. Scratching and post-entries are allowed at the gate.
7. The show committee reserves the right to refuse, limit, accept conditionally, or to cancel awarded prizes; to change any ring or official, to reschedule classes, after due notice to exhibitors.
8. Abuse or inhumane treatment of a horse will not be tolerated. Any unsportsmanlike conduct will also not be tolerated. Above actions may result in elimination.
9. The judge should not be approached and issues can be taken to the show committee.
10. Medical volunteers will be in attendance.
11. ABSOLUTELY NO RIDING outside of schooling and show hours unless cleared with show officials.
12. Only 8 hours of Judging will be available each day. The Show reserves the right to cancel any classes for any reason in an attempt to adhere to these set hours.
13. This show will follow the SHF rule book. We request that participants carefully read all rules. Wherein there is no specific SHF rule, we will consult the EC rule book.
14. STABLING is required for this show. Shavings are available for purchase, and must be ordered along with entry forms/fees. There is absolutely NO tying to your trailer for this show. You are not required to keep your horse overnight if you don't wish to, but you will be assigned a stall for each day of the show.
15. Stakes classes will pay out to 5th place (payouts based on number of entries).
16. The show reserves the right to combine classes, and age categories as deemed necessary.

17. THERE ARE NO PRAIRIE CUP POINTS AWARDED AT THIS SHOW. THIS IS NOT A PRAIRIE CUP SHOW. Only the classes marked with an \* are HERITAGE approved. classes. **STAKES ARE NOT FOR HERITAGE POINTS AT THIS PARTICULAR SHOW\*\*\*\***

Please ensure your SHF membership is current and that you have nominated if you are interested in accumulating points for the awards. Please Note: In light of all of the COVID-19 restrictions that have been put in place over the past year, the SHF is waiving qualifications for the 2021 Heritage Provincial Finals. The requirement to compete in at least two Heritage Circuit shows and place has been waived for 2021 only. However, all horses and riders MUST be nominated prior to September 24, 2021.
