

2021 Talent ID Grant Application/Follow Up

The purpose of the Talent ID Grant is to recognize and financially support those athletes who show the ability, motivation and competition results indicative of someone who is on a pathway to become a high-performance athlete, and to assist them in reaching high-performance levels.

Definitions:

1. High Performance Athletes – those demonstrating excellence in their sport at the highest levels of provincial, national and international competition, with strong competition results in EC or NRHA sanctioned events both inside Saskatchewan and at larger competitions out of the province.
2. Talent ID Athletes – those athletes that are performing on the cusp of high-performance levels, both inside Saskatchewan and at some larger competitions out of province.

Eligibility:

Athletes (Junior or Senior) competing in the FEI (Prairie Cup) disciplines of Dressage, Jumper and Reining. Athletes competing in FEI disciplines of vaulting, endurance, eventing or driving may also be considered, if they have reached the equivalent Talent ID levels. Athletes demonstrating strong competition results in high level Hunters may also be considered.

Criteria

All applicants must:

- Be individual members of the SHF;
- Be permanent residents of Saskatchewan;
- Be actively training and competing in the year of application;
- Be competing in recognized SHF, EC, NRHA, FEI or other such events as credited by a discipline or breed association;
- Submit a training schedule outlining lessons and clinics attended;
- Coaches letter of support
- Submit a schedule of competitions attended and include competition results;
- Demonstrate competency by strong competition results;
- Demonstrate that they support Saskatchewan's equestrian sport community;
- Submit receipts to verify eligible expenditures.
- Submit proof of successful completion of Sask Sport Respect In Sport

Preference will be given to those athletes who are nominated to the Heritage Circuit or Prairie Cup Series. Where the level of competition at a provincial or regional level exceeds that of a national level event, the Grants Committee reserves the right to award funding accordingly.
