- vii. Tickets will be drawn by a method of random selection and witnessed by a minimum of two observers of a non-participating party and a member the Saskatchewan Horse Federation. None of these individuals shall be the person conducting the draw.
 - a. The draw order will be highest prize value drawn first proceeding to lowest prize value.
 - b. Winners will be contacted by telephone by the SHF office and advised how to claim prizes. Once all winners have been contacted, the winners will be announced on the SHF website at <u>www.saskhorse.ca</u>, the SHF Facebook page and in the SHF monthly e-newsletter.
